Member of the Year Award

This award is given to a GCSMPS member who has made the greatest difference to the success, reputation, health and/or function of the chapter in the past year.

The award will be presented during the Greater Cincinnati SMPS Annual Meeting on June 22, 2017. The winner of Member of the Year will receive an award and a \$100 scholarship of their choice towards either:

1. Earning the CPSM certification (if eligible)
2. Attending Build Business (SMPS National Conference) or an SMPS Regional Conference

The recipient must use this scholarship within two years of receiving the award.

Eligibility

Nominee must be a member of GCSMPS, but not a 2016-2017 GCSMPS Board Member.

Criteria

Selection shall be based on the following criteria:

1. Recipient has made significant contributions to the success of GCSMPS over the past 12 months, positively affecting any/all of the following: the chapter's reputation, health, promotion, initiatives, membership, event attendance, event effectiveness, and committee contributions.
2. Recipient goes above and beyond their chapter role to ensure the continued success of GCSMPS.
3. Recipient must be a strong advocate of SMPS both within their firm and the AEC industry.

Selection Process

1. The 2016-2017 GCSMPS Board of Directors will nominate a candidate for this award (no more than one nominee per board member), using the attached nomination form.
2. Each Board Member will evaluate all of the nominees, and will then vote for their #1 and #2 choices. The #1 choices will receive 2 points and #2 choices will receive 1 point.
3. Points will be tallied and a winner will be selected. In the event of a tie, the tied candidates will again be voted upon by the board to select the winner.

Deadline and Requirements

Board members, send one PDF of the entire nomination form for each candidate by 5:00 PM EST on May 26, 2017, to amanda.roehl@kleingers.com. Please include a separate file with the color headshot.

Each package must include the following information in the order stated:

1. **Nomination Form** (see following page) Statement from nominator that is 500 words or less as to why nominee should receive the award. No additional info or attachments can be submitted.
2. **Digital color photo of nominee** – provide a 1-3 MB color headshot in JPG format.
